## RESOLUTION OF THE DEER VALLEY BOARD OF DIRECTORS NO. 07-03 Fining Schedule

WHEREAS, Article VIII, Section 1 of the Protective Covenants of the Deer Valley Subdivision empowers the Board of Directors (Board) to enforce the Rules and Regulations applicable to the Property, and

WHEREAS, Article VI, Section 2 of the Bylaws of the Association defines additional enforcement rights of the Board to enforce rules and regulations of the common property, and

WHEREAS, the Board has determined that it is in the best interest of the Association to establish procedures to enforce the Protective Covenants, ByLaws and Rules and Regulations of the Association.

NOW, THEREFORE, THE BOARD RESOLVES THAT THE FOLLOWING FINING SCHEDULES ARE HEREBY ADOPTED:

1) The Board of Directors is authorized to enforce timely compliance of Covenants, fine and assessment payments from Owners, compliance with the Covenants, Bylaws and Board Resolutions and other policies enacted in accordance with the governing documents by assessing monetary penalties against Owners, their guests, family and renters who are in violation. In the event the violation is not corrected, the Association will avail itself of all remedies available to it under the Declaration. This shall include the right to impose a fine as defined in the schedules below, which shall constitute a lien upon your Lot. Additionally, the Association shall have the right to suspend your voting rights and your rights to use the recreational facilities.
