

**RESOLUTION OF THE DEER VALLEY
BOARD OF DIRECTORS NO. 06-01
General Recreational Facilities Rules**

WHEREAS, Article V, Section 1 of the Protective Covenants of the Deer Valley Subdivision empowers the Board of Directors (Board) to promulgate, modify or delete the Rules and Regulations applicable to the Property, and

WHEREAS, Article VI, Section 1 of the Bylaws of the Association empowers the Board to make and enforce rules and regulations to regulate the use of the common property, and

WHEREAS, the Board has determined that it is in the best interest of the Association to establish rules for appropriate use of the recreational facilities.

NOW, THEREFORE, THE BOARD RESOLVES THAT THE FOLLOWING RECREATIONAL FACILITIES RULES ARE HEREBY ADOPTED:

(a) Good order, proper attire, decorum, and consideration of the rights and comforts of others must be observed at all times in all places while on the Recreational Facilities premises.

(b) No property or furniture of the Recreational Facilities shall be moved from the room or other area in which it is placed without the approval of the Board.

(c) No article belonging to the Association shall be loaned or removed from the Recreational Facilities without written permission of the Board.

(d) Members shall be accountable for misuse and damage to Recreational Facilities property. Willful or careless damage to property shall render the person causing it liable to the full extent thereof.

(e) No subscription, petition, or notice shall be posted on or at the Recreational Facilities without approval of the Board or Recreational Facilities Manager.

(f) No private business or solicitation of any kind shall be transacted on the Recreational Facilities except as may be authorized by the Board.

(g) Certain facilities of the Recreational Facilities may be available for private parties from time to time. Arrangements for private parties or special parties for Members or Member-sponsored groups should be made through the Board of Directors, in advance. If an unusual number of people are involved and/or whenever special service of any kind is desired, it is imperative that the Board be given adequate advance notice. The Board may establish guidelines regarding notice, operations, additional services and hours.

(h) The Association reserves the right to allow persons who are not Members to use the Recreational Facilities at such times and upon the payment of such fees as may be

determined by the Board. Such usage may include, without limitation, private parties and swim meets.

The effective date of this Resolution will be August 1, 2006
